Resolution No. 2014-032

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) FOR THE IMPLEMENTATION OF BUSINESS CAPABILITY DEVELOPMENT PROGRAM UNDER THE BOTTOM-UP BUDGETING WITH A PROJECT COST OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00).

WHEREAS, Sec. 447 of the Local Government Code of 1991 (RA 7160) provides that the Sangguniang Bayan, as a legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Sec. 16 of the Code, as follows:

“SECTION 16. General Welfare. – Every local government unit shall exercise the powers, expressly granted, those necessarily implied there from, as well as powers, necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace & order, and preserve the comfort and convenience of their inhabitants.”

WHEREAS, in a letter dated March 14, 2014 addressed to the Sangguniang Bayan, Hon. Municipal Mayor Suzette T. Alquisada requested for a resolution authorizing her, for and in behalf of the Municipality of Tigbauan, to enter into a MOA with the DTI for the implementation of Business Capability Development Program under the Bottom-Up Budgeting (BUB) with a project cost of One Million Five Hundred Thousand (P1,500,000.00);

WHEREAS, during the regular session of the Sangguniang Bayan on March 17, 2014, the matter was referred to the Committee on Economic Affairs and Investment, chaired by Hon. Ariel I. Bernardo, for appropriate action;

WHEREAS, the implementation of the BUB is one of the major instrumentalities in attaining the Philippine Development Plans goal of inclusive growth and poverty reduction, and promoting good governance at the local level;

WHEREAS, the DTI is one of the participating agencies in the implementation of the BUB projects for 2013;

WHEREAS, the Municipality of Tigbauan is identified as one of the recipient LGU's with approved project "Business Capability Development Program" that is included in the DTI's budget under the GAA for 2013;

WHEREAS, the Municipality of Tigbauan is eligible to implement the approved BUB project as evaluated by the DTI;

WHEREAS, the BUB is intended to the fourteen (14) Basic Sectors namely:

1. Urban Poor
2. Children
3. Women
4. Person with Disabilities
5. Senior Citizens
6. Victims of Disaster & Calamities
7. Non-Government Organization
8. Workers in the Informal Sectors
9. Farmers
10. Formal Labor & Migrant Workers
11. Cooperatives
12. Out-Of School Youth/Youth Sector
13. Fisherfolks
14. Indigenous People

WHEREAS, in order to implement the approved BUB Project, the Municipality of Tigbauan and the DTI need to enter into a MOA to define their respective roles, duties, obligations and commitments therein;

NOW, THEREFORE, on motion of Hon. Ariel I. Bernardo, Chairman, Committee on Economic Affairs and Investment and duly seconded by Hon. Jose Donel Trasporto, Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ronnie Paguntalan,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement with the Department of Trade and Industry for the implementation of Business Capability Development Program under the Bottom-Up Budgeting (BUB) with a project cost of One Million Five Hundred Thousand (P1,500,000.00),

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, to Department of Trade and Industry (DTI) and to all concerned for their information and/or appropriate action.
