RESOLUTION CONFORMING AND ADOPTING LOCAL HEALTH BOARD RESOLUTION NO. 2014-001 –*“RESOLUTION APPROVING THE ALLOCATION OF TEN PERCENT (10%) GROSS INCOME OF THE COLLECTION FROM LABORATORY FEES GENERATED BY THE MUNICIPAL HEALTH OFFICE PER MONTH FOR HONORARIUM OF THE PATHOLOGIST”*.

WHEREAS, a letter dated March 27, 2014 of Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, requesting for the passing of Resolution Conforming and Adopting Local School Board Resolution No. 2014-001;

WHEREAS, Republic Act 7160 provides that the Sangguniang Bayan shall appropriate funds for specific programs, projects, services and activities of the municipality, or for other purposes not contrary to law, in order to promote the general welfare of the municipality and its inhabitants;

WHEREAS, with the further development of our Rural Health Unit, there is an urgent need to develop our laboratory to enhance the basic services of the populace;

WHEREAS, in cases of a 2nd or 3rd class laboratory, there is a need to seek the services of a Pathologist to review the results and calibrate the basic laboratory machines;

WHEREAS, the municipality has intended to the allocation of ten percent (10%) gross income of the collection from laboratory fees generated by the Municipal Health Office for honorarium of the Pathologist;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Renee Librodo-Valencia, Hon. Jose Donel Trasporto, Hon. Ricky Nulada and Hon. Ariel Bernardo,
