RESOLUTION REQUESTING POLICE SENIOR SUPERINTENDENT CORNELIO R. SALINAS, PROVINCIAL DIRECTOR OF ILOILO POLICE, PROVINCIAL OFFICE FOR ADDITIONAL PNP PERSONNEL TO BE ASSIGNED AT THE PNP OFFICE, TIGBAUAN, ILOILO TO REINFORCE AND BOLSTER THE EFFECTIVITY OF THE PNP COMMAND IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, there is a perceived and urgent need for additional PNP Personnel to reinforce the PNP Tigbauan Police Station, which at present has only twenty (21) regular personnel;

WHEREAS, the Municipality of Tigbauan has presently a total population of more or less Sixty Three Thousand Thirty Two (63,032) number of inhabitants that require effective police protection;

WHEREAS, the ideal ratio of PNP personnel for every inhabitant of a locality is 1:1,000 to have peace and order and public safety;

WHEREAS, to thwart and curb the incidence of street crimes, and other serious or heinous offenses, our need for additional PNP personnel is downright urgent and immediate;

NOW, THEREFORE, on motion of HON. RICKY NULADA, Chairman, Committee on Peace and Order and Public Safety and duly seconded by Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Ariel I. Bernardo and Hon. Ronnie T. Paguntalan,

RESOLVED, to Request Police Senior Superintendent Cornelio R. Salinas, Provincial Director Of Iloilo Police Provincial Office For Additional PNP Personnel To Be Assigned At The PNP Office, Tigbauan, Iloilo To Reinforce And Bolster The Effectivity Of The PNP Command In The Municipality Of Tigbauan, Province Of Iloilo,
