RESOLUTION CONFORMING AND APPROVING THE CY 2014 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF BARANGAYS BARROC, BAROSONG, LINOBAYAN, AND CANABUAN THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 14, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2014 Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of Bgry. Barroc, Brgy. Barosong, Brgy. Linobayan and Brgy. Canabuan, to wit:

Barangay Barroc CY 2014 General Annual Budget Involving An Appropriation of P1, 636,154.00, 20% Development Fund in the amount of P320,830.80, and 5% BDRRMF in the amount of P81,807.70 Approved by Sangguniang Barangay on January 6, 2014 and December 16, 2013 respectively and Enacted Under Appropriation Ordinance No. 2014-01;

Barangay Barosong CY 2014 General Annual Budget Involving An Appropriation of P1,250,910.00, 20% Development Fund in the amount of P 242,182.00 and 5% BDRRMF in the amount of P62,545.50 Approved by Sangguniang Barangay on January 6, 2014 and December 16, 2013 respectively and Enacted Under Appropriation Ordinance No. 2014-01;

Barangay Linobayan CY 2014 General Annual Budget Involving An Appropriation of P 897,791.00, 20% Development Fund in the amount of P 177,878.20, and 5% BDRRMF in the amount of P44,889.55 Approved by Sangguniang Barangay on January 4, 2014 and December 21, 2013 respectively and Enacted Under Appropriation Ordinance No. 2014-01;

Barangay Canabuan CY 2014 General Annual Budget Involving An Appropriation of P 976,707.00, 20% Development Fund in the amount of P 193,641.40, and 5% BDRRMF in the amount of P48,835.35 Approved by Sangguniang Barangay on December 28, 2013 and December 14, 2013 respectively and Enacted Under Appropriation Ordinance No. 2013-03;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans and opined that such show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, *Chairperson, Committee on Appropriations* and as duly seconded by Hon. Jose Donel Trasporto, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to conform and approve the CY 2014 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangay Barroc, Barangay Barosong, Barangay Linobayan and Barangay Canabuan, this municipality,
