RESOLUTION REQUESTING THE ASSISTANCE OF HONORABLE CONGRESSMAN OSCAR RICHARD S. GARIN, JR. TO FOLLOW-UP IN CONGRESS THE REQUEST OF THE MUNICIPALITY OF TIGBAUAN FOR THE CONVERSION OF PARARA-JAMOG PROVINCIAL ROAD INTO A NATIONAL ROAD AND FOR SOME UPDATES RELATED THERETO

WHEREAS, the road connecting the barangays south of the Municipality of Tigbauan known as Parara-Jamog Road is classified as a Provincial Road of the Province of Iloilo;

WHEREAS, the Iloilo Provincial Government conducts regular maintenance works on said Parara-Jamog Road due to its rough condition, and has implemented partial concreting for the past years;

WHEREAS, in order to fast tract the much needed concreting of the Parara-Jamog Provincial Road, the Sangguniang Bayan of Tigbauan as per Resolution No. 2013-054 resolved to request for the conversion of said provincial road into a national road, there being more sources of funds for the project from the National Government;

WHEREAS, the Honorable Board Member Dennis T. Valencia of the First District of Iloilo in a letter dated December 10, 2013 to the Sangguniang Bayan of Tigbauan updated that the Resolution requesting for the conversion of Parara-Jamog Provincial Road into a National Road was endorsed to and received by the Congressional Committee on Land Use for its appropriate action;

WHEREAS, the Sangguniang Bayan of Tigbauan welcomed the update from the Honorable Congressman Oscar Richard S. Garin, Jr. through a local newspaper that all national roads in the First District of Iloilo has been concreted;
