RESOLUTION CONFORMING AND APPROVING THE CY 2014 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF BARANGAYS BUENAVISTA, NO.8 (POB.), SERMON, BANTUD, BINALIUAN MENOR, ISAUAN AND BRYY. 7 (POB.), THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 28, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2014 Barangays Buenavista, No.8 (Pob.), Sermon, Bantud, Bin. Menor, Isauan and Brgy. 7 (Pob.), Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans, to wit:

Bantud CY 2014 General Annual Budget Involving An Appropriation of **P893,886.00**, 20% Development Fund in the amount of **P176,627.20**, and 5% BDRRMF in the amount of **P44,694.30** Approved by Sangguniang Barangay on Jan. 13, 2014 and Nov. 3, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-01;

Brgy. Binaliuan Menor CY 2014 General Annual Budget Involving An Appropriation of **P1,031,751.00**, 20% Development Fund in the amount of **P204,150.20** and 5% BDRRMF in the amount of **P51,587.55** Approved by Sangguniang Barangay on Oct. 6, 2013 and Dec.14, 2013 respectively and Enacted Under Appropriation Ordinance No. 2013-02;

Brgy. Isauan CY 2014 General Annual Budget Involving An Appropriation of **P838,590.00**, 20% Development Fund in the amount of **P165,618.00**, and 5% BDRRMF in the amount of **P41,929.50** Approved by

Sangguniang Barangay on Jan. 5, and December 5, 2013, respectively and Enacted Under Appropriation Ordinance No. 2014-001;

Brgy. 7 Pob. CY 2014 General Annual Budget Involving An Appropriation of P1,278,319.00, 20% Development Fund in the amount of P252,523.80 and 5% BDRRMF in the amount of P63,915.95 Approved by Sangguniang Barangay on January 27, 2014 and December 8, 2013 respectively and Enacted Under Appropriation Ordinance No. 2014-001;

WHEREAS, the Municipal Budget Officer have reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
