RESOLUTION FAVORABLY RECOMMENDING THE ACCREDITATION/RECOGNITION OF THE HEREIN LIST OF QUALIFIED NGO'S, PO'S, AND SIMILAR AGGRUPATIONS/ GROUPS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO"

WHEREAS, the Local Government Code 1991, empowers the local sanggunian to call on all community based People's Organizations and Non-Government Organizations, including business and professional groups, and other similar aggrupations to apply with the LGU concerned for membership in the local special bodies;

WHEREAS, in response to this mandate, the Sanggunian Bayan of Tigbauan passed Resolution No.2013-036, "RESOLUTION CALLING ON ALL COMMUNITY BASED ORGANIZATIONS, PEOPLE'S ORGANIZATIONS, NON-GOVERNMENT ORGANIZATIONS AS WELL AS BUSINESS AND PROFESSIONALS AND OTHER SIMILAR AGGRUPATIONS WHETHER PREVIOUSLY ACCREDITED OR SEEKING ACCREDITATION FOR THE FIRST TIME TO APPLY FOR ACCREDITATION FOR MEMBERSHIP IN LOCAL SPECIAL BODIES OF THE MUNICIPALITY";
