RESOLUTION REQUESTING FOR FINANCIAL ASSISTANCE FROM THE OFFICE OF THE GOOD GOVERNOR, ARTHUR DEFENSOR, SR. THROUGH THE OFFICE OF BOARD MEMBER PAUL PARIAN, PCL PRESIDENT OF THE PROVINCE OF ILOILO IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FOR THE PURCHASE OF JETMATIC PUMPS TO ENSURE POTABLE WATER ACCESSIBILITY TO VARIOUS BARANGAYS OF TIGBAUAN, ILOILO.

WHEREAS, securing potable and safe water access is of great help to our people especially those in areas where water is scarce;

WHEREAS, at present, various barangays have been requesting for jetmatic pumps to be used for their traditional water systems established in different areas within the barangay that serve various households;

WHEREAS, local funds are not enough to make possible the purchase and grant of jetmatic pumps to requesting barangays, thus, other sources of fund and assistance is being explored in order to help ensure potable water access to our constituents;

WHEREAS, as PCL President, Honorable Board Member Paul Parian has an existing allocation intended to assist LGUs in the implementation of projects geared towards the promotion of the general welfare of people consistent with the meaningful utilization of the 20% Development Fund through the office of the Honorable Governor Arthur Defensor, Sr. which may be used to help achieve the desired goal to ensure potable water access to our people;
