Resolution No. 2014-079

RESOLUTION DECLARING BARANGAY DAPDAP ORDINANCE NOS. 2013-001 to 2013-008 OF THIS MUNICIPALITY FOR BEING **VALID AND CONSISTENT WITH REPUBLIC ACT 7160**.

WHEREAS, the following ordinances of Barangay Dapdap were submitted to the Office of the Sangguniang Bayan for review last May 16, 2014:

1. No. 2013-001 – “An Ordinance Prohibiting The Burning Of Rice Straw In Barangay Dapdap, Tigbauan, Iloilo And Imposing Penalties For Violation Thereof”
2. No. 2013-002 – “An Ordinance Requiring All Store Owners, Business Establishments, Peddlers and Food Vendors To Secure A Barangay Business Clearance At Barangay Dapdap, Tigbauan, Iloilo”
3. No. 2013-003 – “An Ordinance Regulating the Proliferation of stray dogs in the Barangay Dapdap and Providing Penalty For Violation Thereof”
4. No. 2013-004 – “An Ordinance Regulating The Use Of Multi-Purpose Pavement Of Barangay Dapdap, Tigbauan, Iloilo And Charging Reasonable Fees For The Use Thereof”
5. No. 2013-005 – “An Ordinance On Stray Animals Within The Barangay And Providing Penalty for Violation Thereof”
6. No. 2013-006 – “An Ordinance Regulating Attendance Of All Households In Barangay Assembly Meeting-Regular Or Special”
7. No. 2013-007 – “An Ordinance Prohibiting Any Form Of Public Disturbance In Barangay Dapdap, Tigbauan, Iloilo And Imposing Penalties For Violation Thereof”
8. No. 2013-008 – “An Ordinance Prohibiting And Penalizing Any Kind Of Vandalism In Barangay Dapdap, Tigbauan, Iloilo And Imposing Penalties For Violation Thereof”

WHEREAS, these Barangay Ordinances were referred to this Committee for study, review and recommendations on May 16, 2014 and after a conference and legislative education with the barangay officials on June 10, 2014 at 9:30 in the morning, which was also attended by SB Member Ariel Bernardo, LnB President Ronnie Paguntalan, Vice Mayor Roel Jarina and Brgy. Officials of the barangay concerned. The subject Barangay Ordinances were found to be **VALID and LEGAL** pursuant to Section 391 of RA 7160 of the Local Government Code of 1991 to wit:

SEC. 391 Powers, Duties, and Functions. – (a) *The sangguniang barangay, as legislative body of the barangay, shall:*

- (1) *Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein;*

- (2) Enact tax and revenue ordinances, subject to the limitations imposed in this Code;
- (7) Regulate the use of multi-purpose halls, multi-purpose pavements, grain or copra dryers, patios and other post-harvest facilities, barangay waterworks, barangay markets, parking areas or other similar facilities constructed with government funds within the jurisdiction of the barangay and charge reasonable fees for the use thereof;
- (14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of Barangay ordinances.
- (24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, the same is also consistent with **SECTION 16 of LGC** which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the committee also found out that a public hearing was also conducted by the Barangay concerned to properly inform the people of new legislative measures;

WHEREAS, furthermore, the barangay concerned is reminded of its duty to issue corresponding official receipts for every tax, fees or charges which will be collected pursuant to the above-mentioned barangay ordinances;

NOW, THEREFORE, on motion of HON. JOSE DONEL T. TRASPORTO, Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters and duly seconded by Hon. Virgilio Teruel, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,

RESOLVED, to declare BARANGAY DAPDAP ORDINANCE NOS. 2013-001 to 2013-008 OF THIS MUNICIPALITY FOR BEING **VALID AND CONSISTENT WITH REPUBLIC ACT 7160**,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, to Brgy. Dapdap, Tigbauan, Iloilo, to Liga ng mga Barangay and to all concerned for their information and guidance.
