RESOLUTION CONFORMING AND ADOPTING LPRAT RESOLUTION NO. 01, SERIES OF 2014 "RESOLUTION AMENDING THE IDENTIFIED GRASSROOTS PARTICIPATORY BUDGETING (GBP) PROJECT FROM SUPPLEMENTARY FEEDING PROGRAM TO CONSTRUCTION OF GROUP HANDWASHING FACILITIES OF DAY CARE CENTERS IN THE MUNICIPALITY OF TIGBAUAN, ILOILO IN THE AMOUNT OF FIVE HUNDRED SEVENTY FIVE THOUSAND PESOS (P 575,000)
