RESOLUTION TO OPEN A SEPARATE TRUST FUND ACCOUNT FOR PHILHEALTH FUNDS, PURSUANT TO THE PERFORMANCE COMMITMENT TO THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP)

WHEREAS, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, in a letter dated June 23, 2014 to the Members of the Sangguniang Bayan through Hon. Roel T. Jarina, Vice Mayor and Presiding Officer, requested for the passing of a resolution "*Resolution Open a Separate Trust Fund for PhilHealth Funds, pursuant to our Performance Commitment to the National Health Insurance Program (NHIP)*"

WHEREAS, the Local Government of Tigbauan, through its Rural Health Unit qualified as a Primary Health Care Benefit provider, and as such is bound to comply with the terms as contained in its Performance Commitment to the National Health Insurance Program (NHIP) of the National Health Insurance Corporation (NHIC) or the PhilHealth;

WHEREAS, as a Primary Health Care Benefit provider the local government is entitled to receive funds from PhilHealth, particularly the Per Family Payment Rate (PFPR) fund, relative to its delivery of health care services to qualified PhilHealth beneficiaries;

WHEREAS, as contained in Annex 1.5 of the aforesaid Performance Commitment, the Local Government of Tigbauan pledged to create/maintain a Trust Fund for the release of the PFPR fund;

WHEREAS, the members of the Sangguniang Bayan were enlightened on the requested Trust Fund for PhilHealth funds and other related concerns by the Municipal Rural Health Officer who is the focal person for NHIPs;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations and duly seconded by Hon. Jose Donel Trasporto, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,
