RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE ILOILO PROVINCIAL GOVERNMENT THROUGH, THE HONORABLE GOVERNOR ARTHUR D. DEFENSOR SR. FOR THE IMPROVEMENT OF THE WATER SUPPLY FACILITY OF THE TIGBAUAN PUBLIC MARKET, MUNICIPALITY OF TIGBAUAN

WHEREAS, water and its sustainable supply is vital and indispensable for the operations of every public market in order to maintain the standards of cleanliness and sanitation for the protection of the consuming public;

WHEREAS, population growth, and the consequent increase in the number of consumers and business enterprises render existing public facilities inadequate to meet the current demands;

WHEREAS, the existing water system of the Tigbauan Public Market is no longer sufficient and capable of providing sustainable water supply for drinking and for the upkeep and maintenance of the public market within acceptable standards of cleanliness and sanitation;

WHEREAS, the Tigbauan Market Vendors' Association likewise expressed its similar assessment of the existing water facility and is one with the Sangguniang Bayan of Tigbauan in recognizing the need to immediately address the inadequacy;

WHEREAS, the establishment or rehabilitation of water supply facilities is known to be one of the priority programs of the Provincial Government under the present administration of Governor Arthur D. Defensor, Sr.;

NOW THEREFORE, through the motion of HON. RENEE L. VALENCIA, Chairman, Sangguniang Bayan Committee on Infrastructure, General Services and Civil Service, and duly seconded by Hon. Jose Donel T.
