**Resolution No. 2014-085**

RESOLUTION REMANDING BACK RESOLUTION 2014-004 OF BARANGAY BITAS, TIGBAUAN, ILOILO FOR LACK OF JURISDICTION ON THE PART OF THE SANGGUNIAN TO ACT ON THE REQUEST FOR TRANSFER OF VOTING CENTER.

WHEREAS, the said matter was referred for review and recommendation to the Committee on Rules Ordinances and Legal Matters;

WHEREAS, the Sangguniang Bayan, as local legislative body of the Local Government Unit of Tigbauan has no power to effect the transfer of voting precincts from one place to another for the same power is lodged and exercised by the COMELEC being a independent body, not subject to the jurisdiction of the Local Sanggunian;

WHEREAS, the Committee Chair also made inquiries to the COMELEC Tigbauan Office, and it was found out that the procedure for the transfer of voting precincts from one place to another is commenced through a Petition which must be signed by 2/3 of all Registered Voters of the affected area/s which shall be forwarded to the COMELEC Province for proper indorsement to COMELEC Regional Office going to the COMELEC Central Office;

WHEREAS, as per information, Barangay Bitas residents and registered voters have already complied with the said requirement and the request for transfer of voting precincts is already on process;

NOW, THEREFORE, on motion of HON. JOSE DONEL T. TRASPORTO, Chairman, Committee on Rules, Ordinances, Resolutions & Legal Matters, Chairperson, Committee on Appropriations and duly seconded by Hon. Renee Librodo-Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,

RESOLVED, to remand Back Resolution 2014-004 Of Barangay Bitas, Tigbauan, Iloilo For Lack Of Jurisdiction On The Part Of The Sanggunian To Act On The Request For Transfer Of Voting Center,
