RESOLUTION STRONGLY ENDORSING THE REQUEST OF THE KAPISANAN NG MGA MAY KAPANSANAN SA TIGBAUAN TO PCSO CHAIRPERSON, HON. MARGARITA P. JUICO TO PROVIDE ONE (1) UNIT AMBULANCE FOR THE USE OF PERSONS WITH DISABILITY IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, a letter was received from Kapisanan Ng Mga May Kapansanan Sa Tigbauan (KKT), requesting for a resolution endorsing their request for One (1) Unit Ambulance For The Use Of Persons With Disability In The Municipality Of Tigbauan from the PCSO;

WHEREAS, KKT is a duly constituted organization of Persons With Disability (PWD) who are active partners of the Local Government Unit in advancing the welfare of the sector that they represent;

WHEREAS, the administration of Mayor Suzette Tenefrancia-Alquisada endeavors to improve the general health condition of the municipality by affecting an efficient delivery of basic health services to the community;

WHEREAS, one of the objectives is to acquire one (1) unit ambulance specifically prioritizing persons with disability to use the same in order to respond to their immediate needs especially during emergencies;

WHEREAS, it has been the consensus/decision by members of the August Body to appeal for help from concerned agencies like the PCSO, considering that the said ambulance is one of the priority projects also of the present administration;

WHEREAS, the existing ambulance being used by the Rural Health Unit of this municipality is no longer in good condition and can no longer solely accommodate the increasing demand in the effective delivery of health services to the growing population;


