RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM GOVERNOR ARTHUR D. DEFENSOR SR., THROUGH THE OFFICE OF BOARD MEMBER DENNIS T. VALENCIA, PROVINCE OF ILOILO IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000) FOR STREET CONCRETING AND IMPROVEMENT OF DRAINAGE SYSTEM ALONG LEONARDIA ST. (POBLACION), TIGBAUAN, ILOILO.

WHEREAS, portion of Leonardia St. of this municipality is in very poor condition and requires immediate repair and rehabilitation through concreting;

WHEREAS, the improved condition of the said road will not only be safe and convenient for road users, but benefits the whole municipality as one of the major thoroughfares leading to the public market;
