RESOLUTION FAVORABLY ENDORSING THE ACCREDITATION OF TIGBAUAN CENTRAL ELEMENTARY SCHOOL, TIGBAUAN, ILOILO AS THE TIGBAUAN SPED CENTER IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, B.P. Blg. 232, An Act Providing for the Establishment and Maintenance of an Integrated System of Education states that, *"The State shall promote the right of every individual to relevant quality education regardless of sex, age, creed, socio-economic status, physical and mental condition, social or ethnic origin, political and other affiliation. The state shall therefore promote and maintain equality of access to education as well as the enjoyment of the benefits of education by all its citizens";*

WHEREAS, Section 12 of the P.D. 7277 provides that, *"The State shall ensure that disabled persons are provided with access to quality education and ample opportunities to develop their skills. It shall appropriate steps to make such education accessible to all disabled persons. xxx The State shall take into consideration the special requirements of disabled persons in the formulation of education policies and progress. It shall encourage learning institutions to take into account the special needs of disabled persons with respect to the use of school facilities, class schedules, physical education requirements, and other pertinent consideration";*

WHEREAS, every child with special needs has the right to an educational program that is suitable to his needs and Special Education shares with the regular education basic responsibilities of the educational system to fulfill the right of every child to develop his full potential;

WHEREAS, the Special Education classes of Tigbauan Central Elementary School started with grade IV-VI (fast learners) was organized last school year 2009-2010;

WHEREAS, in June 2012, the school opened the Special Class for children with Special Needs comprising of 25 pupils with intellectual disability, learning disability, autism, behavioral problem, speech impairment;

WHEREAS, as of School Year 2013-2014, there are a total of 35 exceptional children enrolled in the program and the demands for the improvement and the strengthening of the program is also increasing;

WHEREAS, the Local Government Unit of Tigbauan believes in the nobility of the said program and extends its full support in any way it can to see to it that the program’s sustainability and its accreditation will definitely pave the way;

NOW THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Chairman, Committee on Rules, Ordinances and Legal Matters and Vice Chairman of the Committee on Education, and duly seconded by Hon. Marlon Teruñez, Hon. Suzette Marie Hilado-Banno Hon. Ricky Nulada, and Hon. Ariel Bernardo,
