RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-07-14-295 OF ISIDRO MINERVA WITH TCT NO. T-234400, LOT NO. 2-G-2-D, PSD-06-071494 WITH A TOTAL AREA OF 1,557 SQUARE METERS MORE OR LESS, CONTAINING TEN (10) LOTS LOCATED AT BARANGAY NAMOCON, TIGBAUAN, ILOILO.

WHEREAS, the Subdivision Application of **Isidro Minerva** with Subdivision Approval No. SA-07-14-295 with TCT No. **T-234400, LOT NO. 2-G-2-D, PSD-06-071494** with an area of 1,557 square meters containing Ten (10) lots located at Brgy. - e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.


