RESOLUTION CONFORMING AND ADOPTING RESOLUTION NO. 2014-004 OF THE MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE (MDC-ExeCom), RESOLUTION REPROGRAMMING THE AMOUNT OF TWO HUNDRED NINETY SEVEN THOUSAND TWO HUNDRED EIGHTY NINE & 50/100 PESOS (P 297,289.50) FROM VARIOUS BALANCES OF THE 20% CONTINUING APPROPRIATIONS AS OF JUNE 30, 2014 AND THE AMOUNT OF TWO THOUSAND SEVEN HUNDRED TEN AND 50/100 (P 2,710.50) PESOS FROM THE 5% GENDER AND DEVELOPMENT PROGRAM FUNDS, FOR THE MUNICIPAL COUNTERPART IN THE CONSTRUCTION OF THE MULTI- PURPOSE TEEN CENTER

WHEREAS, the Municipal Development Council Executive Committee (MDC-ExeCom) in its meeting last July 22, 2014 at the Office of the Mayor passed Resolution No. 2014-004, approving the reprogramming of various balances of the 20% Continuing Appropriations as of June 30, 2014 and of the 5% for Gender and Development Program funds;

WHEREAS, some balances of the 20% Continuing Appropriations reprogrammed under the aforementioned MDC-ExeCom Resolution No. 2014-004 have been inactive accounts in the Trial Balance which could be better utilized for relevant priority programs of the municipality, as well that funds for the same purposes have also been appropriated in the approved budgets for 2013 and 2014;

WHEREAS, the MDC-ExeCom reprogrammed the amount of Two Hundred Ninety Seven Thousand Two Hundred Eighty Nine & 50/100 Pesos (P 297,289.50) from various balances of the 20% Continuing Appropriations as of June 30, 2014 for the Municipal counterpart in the construction of a Multi-Purpose Teen Center;

WHEREAS, the utilization of funds under MDC-ExeCom Resolution No. 2014-004 aims to promote welfare and development of the youth consistent with the State policy in recognizing their vital role in nation-building; that the state *“shall promote and protect their physical, moral, spiritual, intellectual, and social well being. (It) shall inculcate in the youth the spirit of patriotism and nationalism, and encourage their involvement in public and civic affairs”*;

NOW, THEREFORE, upon the request of the Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations and duly seconded by Hon. Jose Donel Trasporto, Hon. Virgilio Teruel, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,

RESOLVED, to conform and adopt MDC-ExeCom Resolution No. 2014-004, Reprogramming the Amount of Two Hundred Ninety Seven Thousand Two Hundred Eighty Nine & 50/100 Pesos (P297,289.50) from various balances of the 20% Continuing Appropriations as of June 30, 2014, and the amount of Two Thousand Seven Hundred Ten and 50/100 (P 2,710.50) from the 5% Gender and Development Program funds for the Municipal counterpart in the construction of the Multi-Purpose Teen Center;
