RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. **NO. SA-07-14-296 OF RODELITO G. CONADERA ET-AL WITH TCT NO. F-40093, LOT NO. 3378-B**, WITH AN AREA OF S 6,653 QUARE METERS MORE OR LESS, CONTAINING EIGHT (8) LOTS LOCATED AT BRGY. PARARA SUR, TIGBAUAN, ILOILO.

WHEREAS, the Subdivision Application of **Rodelito G. Conadera With TCT No. F-40093 Lot No. 3378-B**, with an Area of 6,653 Square Meters More Or Less, containing Eight (8) Lots Located At Brgy. Parara Sur, Tigbauan, Iloilo with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on July 21, 2014 for authorization and approval;

- Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- This approval does not exempt the proponent from pertinent requirements of other government agencies;
- This approval does not exempt the proponent from securing registration and license to sell from HLURB.


