RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE PROVINCIAL GOVERNMENT THROUGH THE OFFICE OF BOARD MEMBER DENNIS T. VALENCIA, PROVINCE OF ILOILO IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P 200,000) FOR THE PROCUREMENT OF MULTI PURPOSE TENTS OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, in line with its thrust of bringing the government closer to the people, the Local Government Unit of Tigbauan, both its Executive and Legislative branches, have been conducting activities in various sites within the municipality requiring covered venues, but which most identified communities are not equipped of;

WHEREAS, in order to facilitate the smooth, convenient and effective conduct of said public service related activities *directed towards the promotion of the general welfare pursuant to Section 16 of the Local Government Code* availability of multi-purpose tents is very advantageous so that the LGU could provide the needed facility instead of shifting the burden to the concerned communities;

WHEREAS, availability of multi-purpose tents for small community gatherings initiated by the LGU shall also ensure maximum participation or attendance of target constituents who will be spared of the necessary transportation expense in getting to other venues;

WHEREAS, procured multi-purpose tents may likewise be utilized as extension of existing covered structures such as barangay halls, health centers and stage or platforms in cases when programs and activities would require a larger venue;
