**Resolution No. 2014-102**

RESOLUTION CONFORMING AND APPROVING THE BARANGAY ORDINANCES "ADOPTING AND APPROVING THE YOUTH DEVELOPMENT PLAN AND BUDGET FOR CY 2014 AND INCORPORATING THE SAME IN THE BARANGAY DEVELOPMENT PLAN" OF THE BARANGAYS 1 (**POBLACION**), 5 (**POBLACION**), AND **BARROC** OF THIS MUNICIPALITY.

WHEREAS, the subject Ordinances submitted to the Sanggunian was referred to the Committee on Appropriations last August 13, 2014 for appropriate action;

WHEREAS, upon review by the Committee on Appropriations, it was established that the CY 2014 Annual Barangay Budgets of the aforesaid barangays have been conformed and approved by the Sangguniang Bayan in its previous sessions;

WHEREAS, the SK Fund (or Youth Development Budget) subject of this report represents 10% of the barangays' general fund as required under Section 329 of the Local Government Code, as follows:

WHEREAS, the allocation of SK funds which is 10% of the general fund of the aforesaid barangays are in accordance with Republic Act 10632, otherwise known as An Act to Postpone the Sangguniang Kabataan Elections on October 28, 2013, Amending for the Purpose Republic Act No. 9340, and For Other Purposes and its implementing rules and regulations (IRR);

WHEREAS, Section 1, Rule 5 of the IRR of RA 10632, provides that 10% of the general fund of the barangay allocated for SK shall be used by the sangguniang barangay solely for youth development programs or projects until the new set of SK officials have been duly elected and qualified;

WHEREAS, the Youth Development Programs and Projects as detailed in the Youth Development Plan of the aforesaid barangays are consistent with Section 2 (a), Rule 5 of the said IRR, and are classified as:

Capacity Building  
Health Services and Adolescent Reproductive Health Programs  
Out of School Youth Programs  
Socio-cultural and Sports Development  
Disaster Preparedness and Climate Change Adaptation  
Other similar youth related development programs and projects

WHEREAS, Ten (10%) percent but not less than Ten Thousand (P10,000) Pesos of the SK Funds have been reserved by the barangays for the conduct of SK elections in compliance with Section 2(b), Rule 5 of the same IRR;

WHEREAS, Section 1 (e), Rule 7 of the said IRR provides for the inclusion of the Youth Development Plan and Budget in the Barangay Development Plan, which Budget shall authorize the appropriation and disbursements of the SK Funds in accordance thereof;

NOW, THEREFORE, on motion of HON. RENE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations and duly seconded by Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,

RESOLVED, to conform and approve the Barangay Ordinances “Adopting And Approving The Youth Development Plan And Budget For Cy 2014 And Incorporating The Same In The Barangay Development Plan” Of The Barangays **1 (Poblacion), 5 (Poblacion), And Barroc** Of This Municipality,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, to Brgys 1 (Poblacion), 5 (Poblacion), and Barroc, this municipality and to all concerned for their information and/or appropriation action.
