Resolution No. 2014-103

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY – ILOILO PROVINCIAL OFFICE FOR THE IMPLEMENTATION OF TIMBANGAN NG BAYAN PROJECT.

WHEREAS, it is the policy of the State to promote and encourage fair, honest and equitable relations among parties in consumer transactions and protect consumers against deceptive, unfair and unconscionable sales acts or practices;

WHEREAS, the DTI and the partner LGU are the implementing agencies in the regulation of practices relative to weights and measures as specified in Chapter II-Title III of Republic Act 7394 or the Consumer Act of the Philippines;

WHEREAS, the consumer, in order to get the best value for money, needs to determine truly the weight and measure of any article bought in the market;

WHEREAS, for and in consideration of the above-stated premises, both parties hereby agree to undertake to implement the Timbangan Ng Bayan Project, in accordance with the following terms, conditions and stipulations:

- 1. That DTI shall:
 - Procure two (2) weighing scales and fabricate platforms/housing/steel cage for each weighing scale; and
 - Deliver these weighing scales with platform to Tigbauan Public Market located in Tejero St., Brgy. 9, Tigbauan, Iloilo;

2. That the Partner LGU shall:

- Provide materials for the footing and labor for the installation of the platform;
- Identify and provide two strategic areas in Tigbauan Public Market where consumers can access the weighing scales;
- Provide manpower to take charge of the operations and maintenance of the weighing scales;

- Calibrate the weighing scales at regular intervals and shoulder the costs of maintaining the same; and
- Return the weighing scale to the DTI-Iloilo when this becomes unserviceable before the end of this MOA.

WHEREAS, this Memorandum of Agreement shall be effective upon signing by the authorized representatives of both parties and shall be in force for a period of three (3) years;

WHEREAS, after the termination of this MOA or at the end of three (3) years, weighing scales shall be appraised to determine the depreciated value or residual value for purposes of transfer of accountability, sale or disposal by DTI-Iloilo;

WHEREAS, Agreements can be entered into by DTI-Iloilo with the Partner LGU transferring accountability over said weighing scales subject to Commission on Audit (COA) rules and regulations on such transfer;

WHEREAS, this MOA may be pre-terminated on any of the following grounds:

- a. Upon mutual consent of both parties in writing subject to reasonable notice .
- b. In case of non-compliance by the Partner LGU of any of the provisions of the MOA, DTI-Iloilo has the right to terminate this MOA and repossess or pull-out the weighing scales and steel cages and transfer the same to another LGU;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Market and Slaughterhouse and duly seconded by Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to Authorize The Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement With The Department Of Trade And Industry – Iloilo Provincial Office For The Implementation Of Timbangan Ng Bayan Project,
