RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT OF AFFILIATION WITH THE UNIVERSITY OF ILOILO.

WHEREAS, the Municipality of Tigbauan had approved Municipal Ordinance No. 2010-006 – "An Ordinance Adopting the Revised Policies, Procedures and Guidelines Governing Affiliation and Training of Students in the Department of Health (DOH) Applicable in the Rural Health Unit, Tigbauan, Iloilo";

WHEREAS, the development of human health personnel is necessary for the promotion, maintenance and delivery of health services;

WHERAS, the Rural Health Unit of the Municipality of Tigbauan has been available for the training and learning of students from health professional schools, universities and colleges with accredited health and allied health courses and programs in the past years;

WHEREAS, to maintain the quality of this relationship between rural health units and allied schools, this has been governed by Administrative Order No. 26-C, Series of 1982 and Administrative Order No. 13, Series of 1992 of the Department of Health;

WHEREAS, a Contract of Affiliation between the Rural Health Unit of Tigbauan and University of Iloilo has been presented to the Regional Committee on Affiliation and Training of Students for consideration;

WHEREAS, the Regional Committee on Affiliation and Training Of Students finds that the Contract of Affiliation between Rural Health Unit of Tigbauan and University of Iloilo is in accordance with the provisions of Administrative Order No. 5-A dated February 17, 2006 of the Secretary of Health;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Health & Sanitation and duly seconded by Hon. Renee Librodo-Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo;
