## Resolution No. 2014-109

RESOLUTION CONFORMING AND ADOPTING MDRRMC RESOLUTION NO. 2014-001 "RESOLUTION RE-PROGRAMMING THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND PESOS (P750,000) FROM THE CAPITAL OUTLAY OF THE 2011 MDRRM FUND FOR THE PROCUREMENT OF SIX (6) UNITS PORTABLE TOILETS".

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) in its 08 September 2014 meeting at the Session Hall, Tigbauan Municipal Building passed Resolution No. 2014-001 Re-programming MDRRM Capital Outlay Funds of the FY 2011 in the amount of P 750,000 for the procurement of six (6) units portable toilets;

WHEREAS, Section 21 of Republic Act 10121 (*Philippine Disaster Risk Reduction and Management Act of 2010*) provides that ".... not less than 5% of the estimated revenue from regular sources shall be set aside to support disaster risk management activities such as but not limited to the pre-disaster preparedness programs x x x post disaster activities and payment of premiums on calamity insurance";

WHEREAS, the MDRRMC approved procurement of portable toilets is in line with the thrust to strengthen the capability of the Local Government Unit in responding to disaster and crisis situations directed to promote the welfare of our affected constituents and necessary to ensure their comfort, health and sanitation and prevention of diseases;

WHEREAS, the subject procurement as approved by the MDRRMC shall be in accordance with the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 on the utilization of unexpended prior year balances of LDRRM Funds;

NOW, THEREFORE, upon the request of the Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, on motion of Hon. Renee Librodo-Valencia, Chairperson, Committee on Appropriations, and duly seconded by Hon. Jose Donel Trasporto, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Ricky Nulada, Hon. Ariel Bernardo, and Hon. Ronnie Paguntalan, RESOLVED, to adopt and conform MDRRMC Resolution No. 2014-001 "Resolution Re-programming Seven Hundred Fifty Thousand Pesos (P750.000) from the Capital Outlay of the 2011 MDRRM Fund for the Procurement of Six (6) units Portable Toilets",
