Resolution No. 2014 – 112

RESOLUTION AUTHORIZING MUNICIPAL MAYOR SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE IMPLEMENTATION OF "VARIOUS PROGRAMS/PROJECTS FOR LOCAL GOVERNMENT UNITS: PROVISION FOR POTABLE WATER SUPPLY, LOCAL ACCESS ROADS AND OTHER PROJECTS UNDER THE GRASSROOTS PARTICIPATORY BUDGETING PROCESS (GPBP) FORMERLY KNOWN AS BOTTOM UP BUDGETING (BUB)"

WHEREAS, various projects under the Grassroots Participatory Budgeting Process (GPBP) were identified and included in the CY 2013 Budget of pilot-participating national government agencies (NGAs), and for the DILG two (2) projects were approved under the titles (i) Provision for Potable Water Supply and (ii) Implementation of Various Projects for LGUs. For CY 2014, the same projects are still budgeted with the inclusion of a new one, (iii) the Local Access Roads;

WHEREAS, under the said GPBP, the Municipality of Tigbauan is one of the identified Local Government Units to have been granted the "Potable Water Supply System – Level 2" project in the amount of Five Million Pesos (P 5,000,000) with DILG as lead executing agency; the corresponding LGU counterpart amounting to Seven Hundred Fifty Thousand Pesos (P 750,000) have been accordingly appropriated in the Municipality's approved budget for CY 2014;

WHEREAS, in the implementation of the aforesaid "Potable Water Supply System – Level 2" project it is necessary for the LGU through the Local Chief Executive to enter into a memorandum of agreement with the DILG which is lead implementing agency particularly on matters relating to transfer and utilization of funds;

NOW, THEREFORE, upon the request of Mayor Suzette Tenefrancia-Alquisada, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations and duly seconded by Hon. Jose Donel Trasporto, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan;

RESOLVED, to Authorize Municipal Mayor Suzette Tenefrancia-Alguisada, For and In Behalf Of the Municipality of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With The Department of Interior and Local Government (DILG) for the Implementation of "Various Programs/Projects for the Local Government Units: Provision for Potable Water Supply, Local Access Roads and Other Projects under the Grassroots Participatory Budgeting Process (GPBP) formerly known as the Bottom Up Budgeting (BUB)";

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alguisada, Municipal Mayor and all concerned for their information and guidance.
