RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT AND USUFRUCT AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) FOR THE IMPLEMENTATION OF SHARED SERVICE FACILITIES (SSF) PROJECT.

WHEREAS, in a letter dated September 16, 2014, the good Mayor, Atty. Suzette Tenefrancia-Alquisada requested this August Body for the urgent passage of a "Resolution Authorizing The Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement And Usufruct Agreement With The Department Of Trade And Industry (DTI) For The Implementation Of Shared Service Facilities (SSF) Project";

WHEREAS, this matter was considered as urgent for there is a need to implement the Shared Services Facilities (SSF) Project immediately;

WHEREAS, the SSF Project which is a major component of Micro-Small-Medium Entrepreneur (MSME) has a duration of 6 years and aims to improve the competitiveness of MSME by providing them machinery, equipment, tools, systems, skills, and knowledge under a shared system;

WHEREAS, on the part of LGU - Tigbauan, it will manage the packaging and labeling center which aims to develop processed food sector (thru appropriate packaging and labeling equipments).

The said project will benefit a total of 140 MSMEs and increase sales by an average of 150%;

WHEREAS, the 2012 General Appropriations Act (GAA) has earmarked funds under the budget of the Department of Trade and Industry (DTI) to implement its "Big Push" for MSME Development; a key strategy to achieve Government's goal of inclusive growth and jobs generation;

WHEREAS, the SSF Project will support the MSME, within the priority industry clusters;

WHEREAS, the draft of the said MOA and Usufruct Agreement are hereto attached as ANNEXES A & B and shall form as integral parts of this resolution;

NOW, THEREFORE, on motion of HON. ARIEL BERNARDO, Chairman, Committee on Economic Affairs and Investment and duly seconded by Hon. Renee Librodo-Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, and Hon. Ronnie Paguntalan;
