**Resolution No. 2014-115**

RESOLUTION DECLARING AS **LEGAL** AND **VALID** BARANGAY NAPNAPAN SUR ORDINANCE NOS.:

- 001-2014 – “AN ORDINANCE PROHIBITING THE MINOR CHILDREN TO WANDER, SAUNTER, LOITER OR TRUANT ON ANY PUBLIC PLACES AFTER 10:00 PM AND BEFORE 4:00 AM AND PROVIDING PENALTIES FOR VIOLATION THEREOF”
- 002-2014- “ ANTI – VANDALISM ORDINANCE OF NAPNAPAN SUR, TIGBAUAN, ILOILO.”
- 003-2014- “AN ORDINANCE REGULATING THE USE OF BARANGAY ROAD LEADING TO SITIO GINES, NAPNAPAN SUR, TIGBAUAN, ILOILO.”

*WHEREAS, the above-mentioned subject matters were referred to this Committee for review and recommendation. A Committee Meeting presided by the Chairperson of this Committee was conducted on September 10, 2014, 9:30 AM at the SB Session Hall which was attended by the Officials of Barangay Napnapan Sur, Tigbauan, Iloilo with SB Members Ariel Bernardo and Ronnie Paguntalan and after careful study, the committee has the following findings, to wit:*

*All the ordinances were accordingly presented in a public hearing. Item (a) is an adoption of the Municipal Ordinances No. 1992-004, as incorporated in the Code of General Ordinances.*

*WHEREAS, items a-c are all consistent with the provisions of Section 391 of the Local Government Code, to wit:*

**“SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:**

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;**

**(14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;**

**(24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;**

WHEREAS, the same are also consistent with *SECTION 16 of the LGC* which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, during the Committee hearing, the officials were also reminded of the duty to issue corresponding official receipts for any fees/charges which may be collected pursuant to the above-mentioned ordinances;

NOW, THEREFORE, on motion of HON. JOSE DONEL T. TRASPORTO, Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters and duly seconded by Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,
