**Resolution No. 2014-117**

RESOLUTION AUTHORIZING MAYOR SUZETTE TENEFANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – REGION VI FOR THE IMPROVEMENT OF THE TB-DOTS SERVICES IN THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, in line with the objective of the PhilPACT to ensure provision of quality basic TB services and in support to the improvement of health services delivery at the local level the National TB Program (NTP) is sub-allotting funds to the Center for Health Development for the use of LGU's on the provision of TB services and other public health-related programs;

WHEREAS, with the following objectives to improve the delivery of basic TB-DOTS services by the health centers and to augment operational/ functional support to areas for the improvement of their health service implementation;

WHEREAS, the DSWD has currently determined 560 municipalities/ cities for the Conditional Cash Transfer (CCT) program that need improvement on their basic health services;

WHEREAS, the Municipality of Tigbauan is a recipient of Financial Assistance and Conditional Cash Transfer Areas to achieve / sustain the National Tuberculosis Control Program targets in the amount of P200, 000.00 for the Department of Health- Regional Office VI;

WHEREAS, a resolution authorizing the Municipal Mayor Atty. Suzette T. Alquisada to enter into a Memorandum of Agreement with Department of Health is one of the requirements for the release of such funds;
