RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-REGIONAL OFFICE VI RELATIVE TO THE UTILIZATION OF COMMUNITY HEALTH TEAM MOBILIZATION BUDGET IN THE AMOUNT OF FOUR HUNDRED NINETY FIVE THOUSAND PESOS (P495,000.00).

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the functions and responsibilities of the delivery of basic services and other related facilities has been transferred from the DOH to the LGU;

WHEREAS, the Department of Health (DOH), pursuant to its mandate to provide adequate and appropriate funds and human resources for health in marginalized areas entails the delivery of quality health care services in a devolved LGU to include the management of clinical administration of public health aspects;

WHEREAS, the mobilization of the Community Health Teams, (CHTs) is a strategy employed by the Department of health to guarantee that every family in the community is periodically visited and attended by a health provider to ensure achievement of the Millennium Development Goals and Universal Health Care;

WHEREAS, this strategy has a special focus on the Filipino families under the National Household Targeting System (NHTS) for the delivery of key health messages and increase utilization of health care services by the households;

WHEREAS, the Community Health Teams have a critical role in increasing awareness and recognition of health risks among households, promoting healthy behaviors and prompt individuals to seek and utilize health care services particularly among poor families;

WHEREAS, the Municipality of Tigbauan, Province of Iloilo had operationalized the Community Health Teams and recognizes the need to sustain its mobilization to ensure that all NHTS households (based on the July 1, 2011-DSWD NHTS-PR List) specially those in Geographically Isolated and Depressed Areas (GIDA) are visited, profiled, monitored and are able to avail the different necessary health services;

WHEREAS, DOH-RO VI has appropriated funds from the CY 2014 budget to assist the Local Government Unit to cover the management and mobilization expenses of Community Health Teams in the amount of P495,000.00;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Suzette Marie Hilado-Banno, and Hon. Ricky Nulada;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement With The Department Of Health-Regional Office VI Relative To The Utilization Of Community Health Team Mobilization Budget In The Amount Of Four Hundred Ninety Five Thousand Pesos (P495,000.00),
