RESOLUTION **RE-SCHEDULING THE HOLDING OF PUBLIC BIDDING ON THE GRANT OF FISHERY PRIVILEGES, CONCESSIONS, LEASE OR CONTRACTS TO INTERESTED AND QUALIFIED APPLICANTS FOR THE ESTABLISHMENT/INSTALLATION OF FISH CORRALS (PUNOT) OR STATIONARY FISH LIFT NET (TANGKAL-TANGKAL) AND STATIONARY FILTER NETS (SALUDAN) IN THE FISHING ZONES OF TIGBAUAN, ILOILO ON OCTOBER 14, 2014, 9:00 O’CLOCK IN THE MORNING AT THE CONFERENCE ROOM, TIGBAUAN MUNICIPAL BUILDING**

WHEREAS, pursuant to Resolution No. 2014-110 passed by this Sanggunian last September 10, 2014, (entitled: RESOLUTION CALLING FOR THE HOLDING OF PUBLIC BIDDING ON THE GRANT OF FISHERY PRIVILEGES, CONCESSIONS, LEASE OR CONTRACTS TO INTERESTED AND QUALIFIED APPLICANTS FOR THE ESTABLISHMENT/INSTALLATION OF FISH CORRALS (PUNOT) OR STATIONARY FISH LIFT NET (TANGKAL-TANGKAL) AND STATIONARY FILTER NETS (SALUDAN) IN THE FISHING ZONES OF TIGBAUAN, ILOILO AND PRESCRIBING THE GUIDELINES FOR THE CONDUCT THEREOF), the Sanggunian scheduled the public bidding for the fishing zones of this municipality on **September 25, 2014, 9:00 o’clock in the morning at the Tigbauan, Municipal Building Conference Room;**

WHEREAS, in a letter dated September 30, 2014, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor endorsed to this August Body, the *“MINUTES OF THE PUBLIC BIDDING ON THE DIFFERENT FISHING ZONES OF THIS MUNICIPALITY HELD ON SEPTEMBER 25, 2014”* for appropriate action;

WHEREAS, as stated in said minutes, it was declared that there was a failure of bidding since no bidder was present nor was there any interested bidders/parties who submitted their proposed bid;

WHEREAS, hereunder provided are the different fishing zones in the Municipality of Tigbauan, which are the subject of this public bidding with the required minimum amount of bid (as provided for under Chapter 10, Section 1D 21 of the said code);

WHEREAS, during the conduct of the **re-scheduled** public auction/bidding on October 14, 2014, the Bidding Committee shall be guided with the following procedure:

a.) The Pre-qualification Bids and Awards Committee on Fisheries comprising of the *Municipal Mayor as Chairman and with the following (4) Members: 1.)Chairman, Committee on Agriculture, Aquatic Resources and Cooperatives; 2.) Vice Chairman, Committee on Agriculture, Aquatic Resources and Cooperatives; 3.) Municipal Treasurer and 4.) Municipal Agriculture Officer* - shall cause the publication of the notice to bid in the local media, if any, in the bulletin board of the Municipal hall and in two conspicuous places in the municipality for a period of **not less than 10 days prior to the holding of such auction**. The agenda and other relative information to the bidding shall be deliberated by the committee at least one week before such public auction;

b.) Interested and qualified parties (*as provided under Chapter 10 - Article J Section 1.B.6 of the Environment Code of this Municipality*) may submit their proposed Bid in the sealed envelop to the Office of the Municipal Treasurer not later than the bidding time and date (*which is September 25, 2014, 9:00 o'clock in the morning*) together with the non-refundable Bid fee in the amount of Three Hundred Pesos (P300.00) only;

c.) The sealed Bid envelope containing the Bid duly signed by the bidder or his authorized representative will be marked as "PROPOSAL FOR ERECTING -----(FISH CORRAL or LIFT NET or STATIONARY FILTER NET) AT THE DESIRED FISHING ZONE ----- and such proposal shall be accompanied with a cash Bid value (100% of winning Bid);

d.) Bidders or their representatives (*which shall be authorized in writing*) are requested to be present at the designated place during the scheduled bidding time and date specially when bids will be opened. Provided however, that person or persons with Standing Fishery Accounts with the Municipality of Tigbauan are disqualified to participate in the Bidding;

e.) The grant of lease of fishery rights through this public auction shall be for a period of one year which will start on **September 25, 2014 and will expire on September 25, 2015** and in cash basis of 100%.“;

WHEREAS, Pre-qualification Bids and Awards Committee on Fisheries reserves the right to reject any Bids, waive any formality in the Bidding and to accept only such Bids as maybe considered advantageous to the Municipality of Tigbauan ;

NOW, THEREFORE, on motion of HON. RONNIE PAGUNTALAN, Chairperson, Committee on Agriculture, Aquatic Resources And Fisheries and duly seconded by Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ricky Nulada and Hon. Ariel Bernardo;

RESOLVED, **re-schedule the holding of public bidding on** the grant of fishery privileges, concessions, lease or contracts to interested and qualified applicants for the establishment/installation of fish corrals (*punot*) or stationary fish lift net (*tangkal-tangkal*) and stationary filter nets (*saludan*) in the fishing zones of tiggbauan, iloilo on **October 14, 2014, 9:00 o'clock in the morning at the Conference Room, Tigbauan Municipal Building**

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, and to all concerned for their information and/or appropriation action.
