RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE PROVINCIAL GOVERNMENT THROUGH THE OFFICE OF BOARD MEMBER DENNIS T. VALENCIA, PROVINCE OF ILOILO IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) FOR THE IMPROVEMENT OF THE STAGE OF THE TIGBAUAN COVERED GYM, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, recent activities conducted by several socio civic organizations as well as national government agencies highlighted the need to improve the existing facilities of the public plaza particularly the stage of the Tigbauan covered gym;

WHEREAS, the said covered gym and concrete stage are also used as venue of public hearings, trainings, seminars and other capacity development activities, sports development activities and cultural enrichment activities of the local government unit, and must therefore be continuously maintained and upgraded to better meet the needs of the people;

WHEREAS, in order to facilitate the smooth, convenient and effective conduct of the aforesaid activities *directed towards the promotion of the general welfare pursuant to Section 16 of the Local Government Code*, improvement of the existing stage of the covered gym is deemed timely and appropriate, especially in view of the upcoming First Congressional District sports and cultural competition to be hosted by the Municipality of Tigbauan;
