Resolution No. 2014-129

RESOLUTION REMINDING AND INSTRUCTING ALL BARANGAYS IN THE MUNICIPALITY TO PASS THEIR RESPECTIVE APPROVED BARANGAY BUDGETS FOR THE ENSUING CALENDAR YEAR 2015 TO THE SANGGUNIAN BAYAN BEFORE THE END OF DECEMBER 2014 FOR REVIEW AND APPROPRIATE ACTION

WHEREAS, Section 331 (A) of the Local Government Code mandates “the punong barangay to prepare the barangay budget in the manner and within the period” prescribed by the applicable Title of the Code, upon receipt of the statement of income and expenditures from the barangay treasurer who shall submit the same not later than September 15 of each year;

WHEREAS, Section 332 of the Code further provides that “The ordinance enacting the annual budget shall take effect at the beginning of the ensuing calendar year x x x”; such that, as with other LGUs, an ordinance enacting the annual barangay budget, should be passed **by the end of the year** preceding the fiscal year under consideration;

WHEREAS, Section 333(a) of the same Code further mandates that **within ten days(10)** from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished to the Sangguniang Bayan for review;

WHEREAS, some barangays have already complied with the above requirements of the law for the ensuing calendar year 2015, since all documents and information necessary for compliance are already available for use and reference of the punong barangays.

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, Chairperson, Committee on Appropriations, and duly seconded by Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno, Hon. Ariel Bernardo and Hon. Ronnie T. Paguntalan Be It,

RESOLVED, To Remind and Instruct all Barangays in the Municipality to Pass Their Respective Approved Barangay Budget for the Ensuing Calendar Year 2015 to the Sangguniang Bayan Before the End of December 2014 for Review and Appropriate Action,

RESOLVED FURTHER, to furnish copies of this resolution to Hon. Mayor Suzette Tenefrancia-Alquisada, the President of the Liga ng mga Barangays and all concerned for their information and/or appropriate action.
