Resolution No. 2014- 141

A RESOLUTION CONFORMING AND APPROVING THE 2015 ANNUAL INVESTMENT PLAN (AIP), OF THE MUNICIPALITY OF TIGBAUAN FOR CALENDAR YEAR 2015

WHEREAS, the Municipal Development Council of Tigbauan passed Resolution No. 2014-005 approving the Annual Investment Program (AIP) of the municipality for Calendar Year 2015 to be funded out of 20% IRA Fund, General Expenditures Fund (P.S., M.O.O.E., C.O.), MDRRM Fund, GAD Fund and Other Sources;

WHEREAS, the 20% Development Fund in the amount of P 20,641,328.00 is appropriated as embodied in the 2015 AIP which shall be utilized for programs, projects and activities incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, P 5,844,185.95 is appropriated as Local Disaster Risk Reduction and Management Fund (LDRRM Fund) embodied in the LDRRM Plan for the Year 2015 which shall be disbursed and utilized strictly pursuant to the provisions of RA 10121 and its implementing rules and regulations;

WHEREAS, P 5,844,185.95 as Gender and Development (GAD) Fund is also appropriated as embodied in the CY 2015 GAD Plan which shall be disbursed and utilized strictly pursuant to the provisions of law and its implementing rules and regulations;

WHEREAS, the 2015 Annual Investment Program with pertinent attachments reflects the itemized plans, programs and activities, and was indorsed by the local chief executive for appropriate action;

NOW THEREFORE, on motion of Hon. Renee L. Valencia, Chairperson, Committee on Appropriation and duly seconded by Hon. Virgilio Teruel, Hon. Ma. Gerrylin Santuyo- Camposagrado, Hon. Ricky Nulada, Hon. Ariel Bernardo, and Hon. Ronnie Paguntalan,
