## Resolution No. 2014- 142

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH REPRESENTATIVE PEDRO G. TRONO MEMORIAL HOSPITAL AS REFERRAL FACILITY ON MATERNAL CARE PACKAGE (MCP).

WHEREAS, the Local Government Unit of Tigbauan is applying for accreditation from the Philippine Health Insurance Corporation (Philhealth) for its Municipal Health Office, a Non Hospital Health Facility for Maternal Health Package;

WHEREAS, the Local Government Unit of Tigbauan through its Municipal Health Office is a certified Basic Emergency Obstetric Newborn Care (BenONC) Facility rendering maternal delivery services, child and maternal care, and other health care services however, needs a Partner Hospital to accept, admit and manage its referred cases;

WHEREAS, the Pedro G. Trono Memorial Hospital in Guimbal, Iloilo is the nearest government hospital to our municipality, thus, it is considered as the most appropriate Partner Hospital;

WHEREAS, there is a need for Pedro G. Trono Memorial Hospital and the Municipality of Tigbauan to enter into this Memorandum of Agreement to establish the partnership and referral system for the Maternal Care Package;
