RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY INTERESTED CONCESSIONAIRE FOR THE OPERATION OF THE LIM-AO FISHING SITE LOCATED AT BARANGAY BUYU-AN, TIGBAUAN, ILOILO FOR A MINIMUM FEE OF P180,000.00

WHEREAS, the Municipality of Tigbauan has a fishing zone, "LIM-AO", located at Brgy. Buyu-an, Tigbauan and operation of such fishing zone is granted through public bidding as mandated by the Municipal Fishery Code;

WHEREAS, bidding for concession of all Fishery Sites failed for two (2) consecutive times on September 25, 2014 and on October 14, 2014 due to the fact that there were no interested bidders/parties;

WHEREAS, the Municipal Mayor endorsed a letter dated December 2, 2014 to the Office of the Sangguniang Bayan of Mr. Poblete, a registered fisherfolk of Tigbauan;

WHEREAS, the Sangguniang Bayan decided to give authority to the Municipal Mayor Hon. Suzette Tenefrancia-Alquisada for and in behalf of Tigbauan to enter into a negotiated contract with any qualified concessionaire for the operation of the Lim-ao Fishery Site located at Barangay Buyu-an, Tigbauan, Iloilo with the minimum amount of P180,000.00 to be valid until September 25, 2015 and notices shall be sent out to the public not later than this Friday,

NOW, THEREFORE, on motion of Hon. Ma. Gerrylin Santuyo-Camposagrado, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment & Expropriation and duly seconded by Hon. Ariel Bernardo and Hon. Ronnie T. Paguntalan,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in behalf of the Municipality of Tigbauan to enter into a negotiated contract with any interested concessionaire for the operation of the Lim-ao Fishing Site located at Barangay Buyu-an, Tigbauan, Iloilo with the minimum of P180,000.00,
