**Resolution No. 2014-149**

RESOLUTION CONFORMING AND APPROVING THE CY 2015 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS PARARA NORTE, LANAG, CANSILAYAN, BUYU-AN AND 3 (POBLACION)**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 18, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2015 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

**Barangay Parara Norte** CY 2015 General Annual Budget Involving An Appropriation of P1,791,764.00, 20% Development Fund in the amount of P355,952.80, and 5% BDRRMF in the amount of P89,588.20 Approved by Sangguniang Barangay on October 4, 2014, and Enacted Under Appropriation Ordinance No. 2014-03;

**Barangay Lanag** CY 2015 General Annual Budget Involving An Appropriation of P1,379,602.00, 20% Development Fund in the amount of P273,820.40, and 5% BDRRMF in the amount of P68,980.10 Approved by Sangguniang Barangay on September 1, 2014 and September 8, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-02;

**Barangay Cansilayan** CY 2015 General Annual Budget Involving An Appropriation of P941,024.00, 20% Development Fund in the amount of P186,404.80, and 5% BDRRMF in the amount of P47,051.20 Approved by Sangguniang Barangay on September 7, 2014 and August 21, 2014, and Enacted Under Appropriation Ordinance No. 2014-003;

**Barangay Buyu-an** CY 2015 General Annual Budget Involving An Appropriation of P2,280,149.00, 20% Development Fund in the amount of P451,629.80, and 5% BDRRMF in the amount of P114,007.45 Approved by Sangguniang Barangay on October 4, 2014 and August 21, 2014, and Enacted Under Appropriation Ordinance No. 2014-03;

**Barangay 3 (Poblacion)** CY 2015 General Annual Budget Involving An Appropriation of P1,251,213.00, 20% Development Fund in the amount of P245,962.60, and 5% BDRRMF in the amount of P62,560.65 Approved by Sangguniang Barangay on September 1, 2014 and October 6, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-003;

WHEREAS, the Municipal Budget Officer has reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. RENEE LIBRODO-VALENCIA, *Chairperson, Committee on Appropriations* and duly seconded by Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo, and Hon. Ronnie Paguntalan,

RESOLVED, to conform and approve the CY 2015 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangays Parara Norte, Lanag, Cansilayan and 3 (Poblacion), this municipality,
