RESOLUTION GRANTING PRODUCTIVITY ENHANCEMENT INCENTIVE (PEI) TO MUNICIPAL EMPLOYEES AND OFFICIALS OF LGU TIGBAUAN IN THE AMOUNT OF THIRTY FIVE THOUSAND PESOS (P 35,000.00) EACH FOR FY 2014 PURSUANT TO DBM BUDGET CIRCULAR NO. 2014 – 3 DATED DECEMBER 2, 2014

WHEREAS, the Department of Budget and Management issued DBM Budget Circular No. 2014-3 dated on December 2, 2014 providing guidelines on the grant of Productivity Enhancement Incentive (PEI) to Government employees for Fiscal Year (FY) 2014;

WHEREAS, item 9 of DBM Budget Circular 2014-3 provides for the grant of PEI for FY 2014 to employees in LGUs, the rates to be determined by the respective sanggunian subject to the Personnel Services limitation in LGU budgets pursuant to Sections 325(a) of RA 7160;

WHEREAS, grant of PEI to LGU employees and officials will encourage efficiency and integrity, responsiveness and courtesy in the civil service and motivate higher performance and greater accountability in the public sector and ensure accomplishment of commitments and targets set forth in the Philippine Development Plan 2011-2016;

WHEREAS, the Local Finance Committee (LFC), certified that savings from Personal Services in the CY 2014 Annual Budget of the Municipality in the amount of Four million two hundred fourteen thousand (P 4,214,000.00) is available for the payment of PEI of municipal officials and employees per DBM Budget Circular 2014-3 dated December 2, 2014, which Certification is herewith attached as "Annex A";

WHEREAS, the Local Chief Executive is empowered to augment funds for the subject expense granted under Appropriation Ordinance No. 2014-02 dated June 2, 2014;
