

RESOLUTION CONFORMING AND APPROVING THE CY 2014 SUPPLEMENTAL BUDGET OF BARANGAY PARARA NORTE, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 26, 2014 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2014 Supplemental Budget embodying Appropriation Ordinance of Brgy. Parara Norte:

Brgy. Parara Norte Supplemental Budget No. 2014-01 for CY 2014, involving an Appropriation of P25,096.78 and was approved by the Sangguniang Barangay on November 15, 2014.

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
