RESOLUTION CONFORMING AND APPROVING THE CY 2015 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS NAPNAPAN NORTE, 2 (POBLACION), BITAS, BINALIUAN MAYOR, NAGBA AND 6 (POBLACION)**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 2, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2015 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

Barangay Napnapan Norte CY 2015 General Annual Budget Involving An Appropriation of P1,845,536.00, 20% Development Fund in the amount of P347,307.20, and 5% BDRRMF in the amount of P92,276.80 Approved by Sangguniang Barangay on October 6, 2014, and September 29, 2014, respectively and Enacted Under Appropriation Ordinance No. 2014-02;

Barangay 2 (Poblacion) CY 2015 General Annual Budget Involving An Appropriation of P1,356,205.00, 20% Development Fund in the amount of P268,441.00, and 5% BDRRMF in the amount of P67,810.00 Approved by Sangguniang Barangay on October 4, 2014 and Enacted Under Appropriation Ordinance No. 2014-03;

Barangay Bitas CY 2015 General Annual Budget Involving An Appropriation of P1,718,030.00, 20% Development Fund in the amount of P332,706.00, and 5% BDRRMF in the amount of P85,901.50 Approved by Sangguniang Barangay on September 17, 2014 and October 21, 2014, and Enacted Under Appropriation Ordinance No. 2014-01;

Barangay Binaliuan Mayor CY 2015 General Annual Budget Involving An Appropriation of P1,494,092.00, 20% Development Fund in the amount of P295,818.40, and 5% BDRRMF in the amount of P74,704.60 Approved by Sangguniang Barangay on August 24, 2014, and October 14, 2014, respectively and Enacted Under Appropriation Ordinance No. 2014-002;

Barangay Nagba CY 2015 General Annual Budget Involving An Appropriation of P1,193,228.00, 20% Development Fund in the amount of P238,085.60, and 5% BDRRMF in the amount of P59,661.40 Approved by Sangguniang Barangay on September 1, 2014 and September 2, 2014, respectively and Enacted Under Appropriation Ordinance No. 2014-01;

Barangay 6 (Poblacion) CY 2015 General Annual Budget Involving An Appropriation of P1,251,934.00, 20% Development Fund in the amount of P220,986.80, and 5% BDRRMF in the amount of P56,296.70 Approved by Sangguniang Barangay on September 3, 2014 and September 10, 2014, respectively and Enacted Under Appropriation Ordinance No. 2014-002;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Vice-Chairman, Committee on Appropriations (*upon the request and under the sponsorship of Hon. Renee Librodo-Valencia, Chairperson, Committee on Appropriations*) and duly seconded by Hon. Virgilio Teruel, Hon. Marlon Teruñez Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada, Hon. Ariel Bernardo and Hon. Ronnie Paguntalan,

RESOLVED, to conform and approve the CY 2015 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangays Napnapan Norte, 2 (Poblacion), Bitas, Binaliuan Mayor, Nagba and 6 (Poblacion), this municipality,
