**Resolution No. 2015-007**

RESOLUTION CONFORMING AND APPROVING THE CY 2014 SUPPLEMENTAL BUDGETS OF BARANGAYS BUENAVISTA, 8 (POBLACION), NAMOCON, TAN PAEL AND CANABUAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 23, 2014 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2014 Supplemental Budgets embodying Appropriation Ordinances of the following barangays:

***Brgy. Buenavista Supplemental Budget No. 2014-01 for CY 2014, involving an Appropriation of 10,855.27 and was approved by the Sangguniang Barangay on December 19, 2014.***

***Brgy. 8 (Poblacion) Supplemental Budget No. 2014-01 for CY 2014, involving an Appropriation of P65,432.32 and was approved by the Sangguniang Barangay on December 6, 2014.***

***Brgy. Namoccon Supplemental Budget No. 2014-01 for CY 2014, involving an Appropriation of P30,603.75 and was approved by the Sangguniang Barangay on December 9, 2014.***

***Brgy. Tan Pael Supplemental Budget No. 2014-01 for CY 2014, involving an Appropriation of P112,324.03 and was approved by the Sangguniang Barangay on December 12, 2014.***

***Brgy. Canabuan Supplemental Budget No. 2014-01 for CY 2014, involving an Appropriation of P20,305.22 and was approved by the Sangguniang Barangay on December 6, 2014.***

WHEREAS, the review of the Supplemental Budgets embodying Appropriation Ordinances for CY 2014 of the aforementioned Barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned Barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;

RENEE LIBRODO-VALENCIA*), and duly seconded by Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Marlon Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,
