RESOLUTION CONFORMING AND APPROVING THE CY 2015 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS SIPITAN, ISIAN, SAN RAFAEL, TAN PAEL AND ISAUAN**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 23, 2014, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2015 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

Barangay Sipitan CY 2015 General Annual Budget In4,080.00, and 5% BDRRMF in the amount of P51,435.00 Approved by Sangguniang Barangay on September 15, 2014, and October 18, 2014, respectively and Enacted Under Appropriation Ordinance No. 2014-03;

Barangay Isian CY 2015 General Annual Budget Involving An Appropriation of P985,153.00, 20% Development Fund in the amount of P195,530.60, and 5% BDRRMF in the amount of P49,257.65 Approved by Sangguniang Barangay on December 7, 2014 and November 16, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-02;

Barangay San Rafael CY 2015 General Annual Budget Involving An Appropriation of P983,672.00, 20% Development Fund in the amount of P195,434.40, and 5% BDRRMF in the amount of P49,183.60 Approved by Sangguniang Barangay on November 16, 2014 and October 5, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-03;

Barangay Tan Pael CY 2015 General Annual Budget Involving An Appropriation of P1,454,231.00, 20% Development Fund in the amount of P282,946.20, and 5% BDRRMF in the amount of P72,711.55 Approved by Sangguniang Barangay on October 10, 2014 and September 28, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-003;

Barangay Isauan CY 2015 General Annual Budget Involving An Appropriation of P952,130.00, 20% Development Fund in the amount of P188,326.00, and 5% BDRRMF in the amount of P47,606.50 Approved by Sangguniang Barangay on October 5, 2014 and Enacted Under Appropriation Ordinance No.2014-03;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOSE DONEL TRASPORTO, Vice Chairman, Committee on Appropriations (*under the sponsorship of the committee chairperson, HON. RENEE LIBRODO-VALENCIA*), and duly seconded by Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Marlon Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,

RESOLVED, to conform and approve the CY 2015 Annual Budgets, Annual Investment Plans, 20% Development Plans and 5% BDRRMF Plans of Barangays **Sipitan, Isian, San Rafael, Tan Pael and Isauan**, this municipality,
