RESOLUTION CONFORMING AND APPROVING THE CY 2015 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS ATABAYAN, SERMON, 9 (POBLACION), BAGUINGIN**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 7, 2015, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2015 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

Barangay Atabayán CY 2015 General Annual Budget Involving An Appropriation of P2,110,357.00, 20% Development Fund in the amount of P416,471.40, and 5% BDRRMF in the amount of P104,117.85 Approved by Sangguniang Barangay on September 7, 2014 and November 17, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-02;

Barangay Sermon CY 2015 General Annual Budget Involving An Appropriation of P982,751.00, 20% Development Fund in the amount of P195,050.20, and 5% BDRRMF in the amount of P49,137.55 Approved by Sangguniang Barangay on September 16, 2014 and September 8, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-03;

Barangay 9 (Poblacion) CY 2015 General Annual Budget Involving An Appropriation of P1,323,687.00, 20% Development Fund in the amount of P256,337.40 and 5% BDRRMF in the amount of P64,184.35 Approved by Sangguniang Barangay on November 24, 2014 and October 5, 2014, respectively, and Enacted Under Appropriation Ordinance No. 2014-003;

Barangay Baguingin CY 2015 General Annual Budget Involving An Appropriation of P2,347,990.00, 20% Development Fund in the amount of P464,598.00, and 5% BDRRMF in the amount of P117,399.50 Approved by Sangguniang Barangay on December 8, 2014 and Enacted Under Appropriation Ordinance No. 2014-01;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
