RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MR. JOSE ZACEL LOGRONIO, FOR THE ESTABLISHMENT OF A DIAGNOSTIC X-RAY LABORATORY.

WHEREAS, the Municipality of Tigbauan is comprising of 52 barangays and has a total population of 65,000 more or less;

WHEREAS, the Municipality of Tigbauan has one (1) Main Health Station and 13 Barangay Health Stations that caters for the basic health services of its constituents;

WHEREAS, the Municipal Health Center has been renovated last 2014 and a space for Radiologic Examination has been allotted;

WHEREAS, since the Municipality of Tigbauan has no capacity to operate the Diagnostic X-ray Laboratory, thus this public/private partnership has been made;

WHEREAS, one of the aims of the municipality is to provide access to quality and affordable Diagnostic X-Ray Laboratory services to the people;

WHEREAS, in order to promote a public/private partnership to uphold the general welfare of the people, the Sangguniang Bayan hereby authorizes the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada to enter into a Memorandum of Agreement with Jose Zacel Logronio for the establishment of a Diagnostic X-ray Laboratory in the Municipality of Tigbauan (*attached is a copy of the said MOA which forms part of this resolution*);
