**Resolution No. 2015- 019**

**RESOLUTION CONFORMING AND ADOPTING THE RESOLUTION OF THE MUNICIPAL LOCAL SCHOOL BOARD UPGRADING LINO FLORES PRIMARY SCHOOL TO AN ELEMENTARY SCHOOL, THEREBY RENAMING IT TO LINO FLORES ELEMENTARY SCHOOL**

**WHEREAS,** Revised Guidelines on the Naming and Renaming of Streets, Public Schools, Plazas, Building, Bridges and other Public Structures issued by the National Historical Commission provides among others:

- a. The sanggunians of component cities and municipalities may, in consultation with the National Historical Institute, change the name of streets, roads, schools, health facilities or any other public place or building within its territorial jurisdiction (see “c” Sec. 13 of Local Government Code)
- b. Renaming of a public school shall be made only upon the recommendation of the local school board concerned, while those of public hospitals, health centers, and other health facilities shall be made only upon the recommendation of the local health board concerned (Letters “e” and “f” of Section 13 of Local Government Code)
- c. A change of name cannot be made unless for a justifiable reason and, in any case, not oftener than once every ten (10) years. (see letter “d” of Sec. 13 of Local Government Code);

**WHEREAS,** Lino Flores Primary School has already been assigned additional Teachers by the Department of Education, thereby authorizing it to function as a full elementary school starting in school year 2014-2015.

**WHEREAS,** said school has already complied with all the requirements for upgrading;

**NOW THEREFORE,** on motion of Hon. Ma. Gerrylin Santuyo-Camposagado, Chairperson, Committee on Education and duly seconded by Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno, Hon. Ariel Bernardo, and Hon. Ronnie T. Paguntalan,

**RESOLVED, AS IT IS HEREBY RESOLVED, to Conform To And Adopt The Resolution Of The Local School Board To Upgrade Lino Flores Primary School To An Elementary School, Thereby Renaming It To Lino Flores Elementary School;**

**RESOLVED FURTHER,** to furnish copies of his resolution to the Sangguniang Panlalawigan, the Department of Education through the Division of Iloilo and Regional Office 6, and the National Historical Commission for their perusal, guidance and information.
