RESOLUTION REQUESTING ASSISTANCE OF THE PROVINCIAL GOVERNMENT THROUGH THE HONORABLE GOVERNOR ARTHUR D. DEFENSOR, SR. FOR THE CONCRETING OF CORDOVA TO MAMBONG PROVINCIAL ROAD PASSING BARANGAY BAROSONG, THIS MUNICIPALITY

WHEREAS, the road connecting Barangay Cordova of the Municipality of Tigbauan and Barangay Mambong of the Municipality of Leon, passing through Barangay Barosong, Tigbauan, is classified as a Provincial Road of the Province of Iloilo;

WHEREAS, the Iloilo Provincial Government conducts regular maintenance works on said Cordova to Mambong Road due to its rough condition, and has implemented partial concreting in the past;

WHEREAS, the maintenance works and partial concreting done is greatly appreciated by the inhabitants of affected barangays having promoted their comfort and convenience, enhanced health and safety and provided ease in bringing agricultural produce to the markets, thus supporting their agricultural, economic and livelihood activities;
