RESOLUTION DESIGNATING MS. ELMA G. TIONSAY, OIC, OFFICE OF THE MUNICIPAL TREASURER AS ONE OF THE OFFICIAL SIGNATORIES IN ALL OFFICIAL TRANSACTIONS WITH THE LAND BANK OF THE PHILIPPINES (LBP), DEVELOPMENT BANK OF THE PHILIPPINES (DBP), AND PHILIPPINE VETERANS BANK (PVB), IN LIEU OF MRS. MA. TERESA TAGUMPAY.

WHEREAS, Mrs. Ma. Teresa Tagumpay, the Officer-in-Charge of the Treasury Office of the Municipality of Tigbauan and one of the official signatories in bank transactions of the LGU has retired from government service effective March 1, 2015;

WHEREAS, as per Regional Special Personnel Order No. 026-2015 of the Bureau of Local Government Finance, *“Ms. Elma G. Tionsay was designated as In-Charge of Office, Office of the Municipal Treasurer, Tigbauan, Iloilo, effective March 2, 2015, in lieu of Mrs. Ma. Teresa Tagumpay;*
