Resolution No. 2015- 039

RESOLUTION APPROVING THE HOLDING OF COCKFIGHTING AT THE FOLLOWING BARANGAYS: PARARA NORTE, NAPNAPAN SUR, NAPNAPAN NORTE AND CANABUAN, THIS MUNICIPALITY.

WHEREAS, the following barangays have forwarded to this August Body their resolutions:

Barangay Parara Norte Resolution No. 17-15-“Resolution Requesting The Good Office Of The Honorable Sangguniang Bayan Of Municipality Of Tigbauan, Iloilo For The Approval To Hold A Three (3) Days Cockfighting Event On March 17, 21 & 22, 2015 At Barangay Parara Norte, Tigbauan, Iloilo In Connection Of Their Annual Fiesta”

Brgy. Napnapan Sur Resolution No. 011-2015-“Resolution Requesting Approval from the Honorable Sangguniang Bayan of Tigbauan, Iloilo To Hold A Cockfighting Event on May 13 and 14, 2015 in Barangay Napnapan Sur, Tigbauan, Iloilo”

Barangay Napnapan Norte Resolution No. 007-2015-“Resolution Requesting The Honorable Sangguniang Bayan Members Of The Municipality Of Tigbauan, Province Of Iloilo To Allow Barangay Napnapan Norte, Iloilo To Hold A Cockfight On May 13-14, 2015 In Line Of Its Annual Fiesta Celebration”

Brgy. Canabuan Resolution No. 15-2015 – “Resolution Requesting the Honorable Sangguniang Bayan of Tigbauan, Iloilo to Grant Permit for Holding 2 Days Cockfighting Event on April 4 and 5, 2015 in Barangay Canabuan, Tigbauan, Iloilo in Connection of the Celebration of Patronal Annual Fiesta”.

WHEREAS, on December 26, 2013, this August Body passed Municipal Ordinance No. 2013-005, entitled: “AN ORDINANCE GRANTING A.P. TENDERO SPORTS ARENA-GALLERA DE TIGBAUAN, A FRANCHISE TO ESTABLISH, MAINTAIN AND OPERATE A COCKPIT IN THE MUNICIPALITY OF TIGBAUAN”;

WHEREAS, on December 27, 2013 said ordinance was forwarded to the Sangguniang Panlalawigan for review and the same was returned and declared as legal and valid;

WHEREAS, Sec. 7.2, Sec. 7.3 & Sec. 7.4 of said ordinance provide:

“**Section 7.2.** In the absence of licensed cockpit in the barangay, cockfighting maybe allowed during the celebration of barangay annual fiesta for not more than three (3) days to be held in the place provided for cockfighting; Provided, however, that Sangguniang Bayan resolution and Mayor’s permit shall be secured prior to the scheduled cockfighting. In the event of conflict of schedule of cockfighting between the licensed cockpit and the barangay, the former shall prevail and the barangay cockfight shall be held before or after the scheduled cockfight in the licensed cockpit;

Section 7.3 Prerequisites Of Holding Cockfighting In The Barangay. Barangay concerned shall be responsible in processing all the requirements needed in conducting cockfighting in the barangay. Two (2) weeks before the holding of cockfighting, concerned barangay shall pass a resolution addressed to the Sanggunian Bayan and copy furnished the cockpit franchisee for proper action and/or approval. Only upon approval of the cockpit franchisee and the Sangguniang Bayan, the barangay shall process their Mayor’s permit and pay corresponding fees at the Municipal Treasurer’s Office.

Section 7.4. Only licensed cockpit personnel shall administer the cockfighting in the franchise cockpit and in every barangay fiesta celebration with the presence of one (1) personnel from the Municipal Treasurer’s Office.”

WHEREAS, this August Body hereby approves the conduct of such activity subject to compliance by the barangays concerned of the said ordinance particularly with regard to the aforementioned provisions;

WHEREAS, non-compliance of the requirements on the part of the barangays concerned shall be sufficient cause for the cancellation of this approval and/or legal action;

NOW, THEREFORE, on motion of HON. RONNIE PAGUNTALAN, *Chairman, Committee on Barangay Affairs* and duly seconded by Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Ariel Bernardo,

RESOLVED, to approve the Holding Of Cockfighting At **Barangays: Parara Norte, Napnapan Sur, Napnapan Norte and Canabuan**, This Municipality,

RESOLVED FURTHER, to forward copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, to Barangays: Parara Norte, Napnapan Sur, Napnapan Norte and Canabuan, and all concerned for their information and/or appropriate action.
