RESOLUTION EXPRESSING SYMPATHY AND HEARTFELT CONDOLENCES TO THE BEREAVED FAMILY OF THE LATE 2LT DOROTEO T. MOMBLAN, DISTRICT COMMANDER, VETERANS FEDERATION OF THE PHILIPPINES OF THE 1ST DISTRICT OF ILOILO

WHEREAS, the late 2LT Doroteo Tupas Momblan(Ret.) was a true-blooded Tigbaueno, and was born on January 1, 1925 at Tupas St., Tigbauan, Iloilo;

WHEREAS, during his lifetime, 2Lt. Doroteo Momblan was an epitome of gallantry and heroism of a Filipino Youth when he served as a Philippine Scout during World War II against the Japanese Imperial Army and joined the Philippine Battalion, the 10th Battalion Combat Team (10th BCT), a Philippine Army contingent of the United Nations Forces that fought in the Korean War in the years 1950 to 1953;

WHEREAS, the late 2LT Doroteo Tupas Momblan was a retired member of the Philippine Constabulary in 1980 and served the District Commander of the Veterans Federation of the Philippines in the 1st District of Iloilo until his death on February 19, 2015;
