**Resolution No. 2015-043**

RESOLUTION SEPARATING BARANGAYS PARARA SUR AND PARARA NORTE FROM BUYUAN HEALTH STATION AND CREATING PARARA SUR HEALTH STATION AS THE HEALTH STATION OF BRGYS. PARARA SUR AND PARARA NORTE.

WHEREAS, the Municipality of Tigbauan is located in the 1<sup>st</sup> District of Iloilo;

WHEREAS, as the latest census, the Municipality of Tigbauan has a total population of 65,114 and a total households of 13,291;

WHEREAS, the Municipality of Tigbauan has one main health center and 13 barangay health stations which cater the basic health needs of its populace;

WHEREAS, Buyu-an Health Station caters a total of **8,616 population** (*distributed as follows: Brgy. Buyu-an 3,707, Brgy. Parara Sur 2,614 and Brgy. Parara Norte 2,295*) comprising a total of **1,771 households** (*distributed as follows: Brgys. Buyu-an 743, Brgy. Parara Sur 552 and Brgy. Parara Norte 476*);

WHEREAS, the ratio of one (1) midwife is 1:5000 as mandated by the Department of Health thus, separation of these two barangays from their mother Health Station and the creation of a new Health Station is really needed;

WHEREAS, Barangay Supa and Barangay Cansilayan which are part of Bagacay Health Station will be transferred to Buyu-an Health Station in order to be more accessible to them;

WHEREAS, Parara Sur Health Station will be the Health Station of Barangays Parara Sur and Parara Norte;

NOW, THEREFORE, on motion of HON. ROEL T. JARINA, Chairman, Committee on Health and Sanitation and duly seconded by Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Marlon Teruñez, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Suzette Marie Hilado-Banno, Hon. Ricky Nulada and Hon. Ariel Bernardo,

RESOLVED, to separate Barangays Parara Sur and Parara Norte from Buyuan Health Station and to create Parara Sur Health Station as the Health Station Of Brgys. Parara Sur and Parara Norte,

RESOLVED, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality, to Dr. Josefa T. Monserate, Municipal Health Officer, and to all concerned for their information and/or proper action.
