RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH ILOILO PROVINCIAL GOVERNMENT FOR THE CONSTRUCTION OF LEACHATE POND

WHEREAS, Republic Act No. 9003 (R.A. 9003) otherwise known as the *“Ecological Solid Waste Management Act of 2000”* was passed and made into a law on the 26th day of January 2001; pursuant to the provision of R.A. No. 7160, otherwise known as the Local Government Code, the LGU’s shall be primarily responsible for the implementation and enforcement of environment laws;

WHEREAS, under R.A. 9003, LGU’s are mandated to implement the aforementioned law; in 2003 the Province of Iloilo has adopted the *“Ecological Solid Waste Management Program”*;

WHEREAS, the program promotes proper solid waste management in the whole Province and ultimately help in eradicating problems caused by garbage;

WHEREAS, to avoid groundwater contamination, there is a need to construct a leachate collection facility which aimed at collecting leachate generated from the dumpsite before channeling it to the pre-determined facility for biological treatment;

WHEREAS, in consideration of the foregoing premises, the parties hereby agree to jointly work and cooperate effectively in the construction of Leachate Pond with the following responsibilities:

A. The Iloilo Provincial Government shall:

1. Provide the needed funds in the construction and establishment of leachate Pond;
2. Provide technical and other forms of assistance for the successful implementation of the project;
3. Conduct Information, Education Campaign (IEC) and training on the management and maintenance of the pond and its environmental implications;
4. Conduct regular monitoring and gather footages of the projects for the appropriate reporting and to make sure that the facilities are functioning and taken cared by the SECOND PARTY.

B. The Municipality of Tigbauan shall:

1. Responsible for providing the design and work program of the project;
2. Responsible for providing plant species for biological treatment
3. Responsible for the care and maintenance of the facility;
4. Conduct regular inspection of the facility and see to it that it is in good condition and functional;
5. Submit progress and development reports of the project and any problem which may arise.

NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO – CAMPOSAGRADO, *Chairperson, Committee on Environmental Protection, Housing, Land Utilization, Zonification & Assessment* and duly seconded by Hon. Jose Donel T. Trasporto, Hon. Renee Librodo-Valencia, Hon. Virgilio Teruel, Hon. Suzette Marie Hilado-Banno and Hon. Ronnie Paguntalan,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With Iloilo Provincial Government For The Construction Of Leachate Pond,

RESOLVED FURTHER, to furnish copies of this Resolution to the Iloilo Provincial Government, to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality and to all concerned for their information and/or appropriate action.
